THIS AGREEMENT is entered into by and between The Pawber Shop SF LLC, and dog owner

- 1) I (Owner) represent that I am the legal owner of the above named dog(s) and I assume all risks, dangers, and responsibility for injuries to the named dog(s). Owner understands and agrees that Owner is solely responsible for any harm while Owner's dog(s) is/are attending Daycare.
- 2) \*PHOTO AND VIDEO RELEASE: We love to post pictures and videos on social media, our website, and/ or use them as ads. Owner agrees to allow The Pawber Shop SF to use Owner's pet's name and any images or likeness of Owner's pet taken while he/she is at The Pawber Shop SF, in any form, for use at any time, in any media, marketing, advertising, illustration, trade or promotional materials without compensation, and Owner releases to The Pawber Shop SF all rights that Owner may possess or claim to such image, likeness, recording, etc.

- 3) **DOG'S HEALTH:** Owner further understands and agrees that Owner's dog(s) are healthy and will at all times while attending The Pawber Shop SF have current vaccinations for rabies, distemper and Bordetella. Owner is not enrolling any dog that has any condition that could potentially jeopardize the health of other dogs or people and has not had any potentially communicable condition within 30 days prior to enrollment. Owner further understands that even if Owner(s) dog is vaccinated for Bordetella (Kennel Cough) there is a chance that the Owner's dog can still contract Kennel Cough. Owner agrees that Owner will not hold The Pawber Shop SF responsible if Owner's dog(s) contracts Kennel Cough or other dog-dog transmitted ailments.
- 4) **FLEA/TICK FREE:** All dogs must be flea/tick free. Should a dog be observed to have fleas or ticks, a flea/tick bath treatment will be applied and charged to the owner at a rate depending on severity and size of dog.
- 5) **GROUP PLAY:** All dogs must pass a general behavior assessment in order to attend dog-dog group play. No dog may be admitted to group play who shows any signs of any type of aggression. Owner further understands and agrees that in admitting Owner's dog(s) to dog-dog group play, Owner is representing to The Pawber Shop SF that Owner's dog(s) is/are in good health and have not harmed, shown aggression, or exhibited any threatening behavior towards any person or other dogs. Any dog demonstrating aggression or other behavior deemed unacceptable by The Pawber Shop SF staff may be required to leave daycare/boarding.

- 6) **RELEASE OF LIABILITY:** Owner understands and agrees that during normal dog play, Owner's dog may sustain injuries. Dog play is monitored by The Pawber Shop SF staff to best avoid injury, but scratches, punctures, torn ligaments, and other injuries may occur despite the best supervision. Owner further understands and agrees that neither daycare/boarding nor any of its employees, staff, or volunteers will be liable for any illness, injury, death, and/or escape of Owner's dog(s) provided that reasonable care and precautions are followed, and Owner hereby releases The Pawber Shop SF's staff or volunteers of any liability of any kind whatsoever arising from or as a result of Owner's dog(s) attending The Pawber Shop SF.
- 7) **PERSONAL PROPERTY:** Owner understands that Owner is solely responsible for any harm, including to any other pet(s), to the employees or invitees of The Pawber Shop SF, or to the equipment, facilities, or other property of The Pawber Shop SF, caused by Owners dog(s). Owner also agrees that The Pawber Shop SF shall not be responsible or liable for any lost or damaged personal property belonging either to Owner or Owner's pet.
- 8) **FOOD/MEDS:** The a Pawber Shop SF will ONLY feed Owners dog dry food. The Pawber Shop SF will not be responsible for administering any meds to Owners dog. Owner agrees that it is the Owner's responsibility to leave an adequate supply of food for Owner's dog(s) during the entire time Owner's dog is cared for by The Pawber Shop SF.
- 9) **VETERINARIAN LIABILITY AND CARE:** In the event of a medical emergency Owner agrees to allow The Pawber Shop SF to obtain medical treatment for Owner's dog(s). Owner agrees to be fully responsible for the cost of any such medical treatment.
- 10) **WEAKENED IMMUNE SYSTEM:** Owner understands special-needs dogs, young puppies, and senior dogs naturally have a higher risk of injury, stress-related illnesses, weakened immune system, or exacerbation of any pre-existing condition. As such, by using our facility for daycare or grooming the Owner is waiving any claim for injury or illness experienced by the Owner's dog while in our care.
- 11) **ELDERLY DOGS:** Owners of elderly dogs (approaching the end of life) need to know if in the event Owner's dog passes on while in our care, if Owner cannot be reached, our policy is to transport Owner's dog to Owner's home or vet.
- 12) **GROOMING** expense to be paid if Owner's dog(s) nails are too long and cause breaking of skin or deep scratches to staff, volunteers, and/or other dogs. In addition if Owner's dog(s) happens to soil their fur we will bathe them at Owner's expense. The Pawber Shop SF standard grooming rates will apply
- 13) **PREPAID PACKAGES:** Owner understands that prepaid daycare packages require a 6 month autopay commitment and expire 12 months from date of purchase. If Owner purchases a membership package and Owner's dog is turned away from daycare services The Pawber Shop SF will cancel autopay at no expense to Owner and will provide a refund at a prorated rate.
- 14) **PAYMENTS FOR WALK INS/NON MEMBERS:** Payments are due and payable at the end of each visit. Single days and non-member packages can be purchased online. All major credit cards are accepted.

- 15) **CANCELLATION / NO-SHOW POLICY:** Cancellations must be done 48-hours prior to the reservation date. If cancellation notice is less than 48-hours a 20% fee will apply.
- 16) **OPEN/CLOSING TIME:** Monday Friday drop off time is between 8am-9am. Monday-Friday pick up time is between 5pm-6pm. Owner agrees that if Owner's dog(s) is/are not picked up by closing time of 6 p.m. California time, then a late fee of \$1 per minute will apply.
- 17) **RIGHT OF REFUSAL:** The Pawber Shop SF reserves the right to refuse admittance to any dog or dismiss any dog that does not meet or maintain the health, temperament or other daycare standards. The determination shall be made at the sole discretion of The Pawber Shop SF staff.
- 18) **FULL FORCE AND EFFECT:** Owner further understands and expressly agrees that each and every of the foregoing provisions contained in paragraphs 1-18 shall be in force and effect and shall apply to each and every occasion on which Owner's dog(s) stays with The Pawber Shop SF for daycare or other services, as the case may be. This Agreement shall remain in full force and effect between the parties until and unless otherwise canceled or superseded in writing signed by the parties.

Owner hereby certifies that Owner has read and understands this Waiver and Release of Liability and the regulations set forth above. By signing this agreement, Owner agrees to be bound by its terms and conditions.
